The Trilateral Agreement in Respect of Reforming the 1965 Agreement

The Trilateral Agreement in Respect of Reforming the 1965 Agreement (referred to as the "Trilateral Agreement") is a provisional agreement reached by Chiefs of Ontario, Nishnawbe Aski Nation, and Canada that details how the parties will work together to drive forward comprehensive reform of the *1965 Indian Welfare Agreement*.

Background

1965 INDIAN WELFARE AGREEMENT

In 2016, the CHRT ordered Canada to reform the *1965 Indian Welfare Agreement* (the "1965 Agreement") – a cost-sharing agreement between Canada and Ontario that sets out the formula Canada uses for reimbursing Ontario for the cost of delivering social assistance, childcare, homemaking, and child and family services on-reserve.

Work to reform the 1965 Agreement has not yet begun.

The provisional Final Agreement on Long-Term Reform of the First Nations Child and Family Services Program in Ontario (referred to as the "Ontario Final Agreement") contains a commitment from Canada to work with COO and NAN on an expedited basis to pursue reform of all program areas covered under the 1965 Agreement with the Government of Ontario – not just child and family services on-reserve. The Trilateral Agreement picks up where the Final Agreement leaves off, detailing how COO, NAN, and Canada will work together.

The Trilateral Agreement would come into effect on April 1, 2025 if it is ratified by NAN Chiefs-in-Assembly and COO Chiefs-in-Assembly at the upcoming Special Chiefs Assemblies (details below).

The Trilateral Agreement contains the following commitments:

- commitment by COO, NAN, and Canada to create a work plan outlining how we will reach out to the Government of Ontario and identifying substantive subjects for discussion with the Government of Ontario by May 31, 2025
- funding to COO and NAN to carry out the activities set out in the work plan. This funding includes amounts to support engagements, research, legal fees, and the Special Chiefs Assemblies required to ratify any reformed agreement.
- commitment that Canada will take the position that COO and NAN be given the opportunity to fully participate in discussions with Canada and the Government of Ontario in respect of reforming the 1965 Agreement
- commitment by Canada to not amend, replace, or terminate the 1965 Agreement or enter into a Reformed 1965 Agreement without consultation with COO and NAN

- commitment by Canada to make best efforts to reach an agreement on a reformed 1965
 Agreement with Ontario by March 31, 2027 and to discuss next steps with COO and NAN if a reformed agreement cannot be reached by that date
- Outside of the Ontario Final Agreement, ISC has committed to continue to fund First Nations in Ontario to access funding at actuals to support the unmet need for First Nation Representative Services to First Nation children and families residing off-reserve until March 31, 2027, subject to Canada's approval processes and terms and conditions. Funding for post-March 31, 2027 is to be negotiated.
